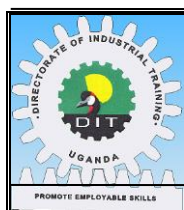

Re: Structures of Assessment fees, charges for Accreditation of Assessment Centres and other charges effective from January 2015

The Directorate of Industrial Training (DIT) is directly responsible for promoting quality assurance interventions in the Business, Technical, Vocational Education and Training for both public and private sector. In order to fulfill this mandate, section 14(f) and 18(b) of the BTVET Act 2008 empowers the Directorate and Industrial Training Council (ITC) to determine and approve fees payable under this Act. The structures of fees payable to DIT are scheduled as follows:-

a) Assessment fees

(i) Modular Assessment(for Partial Qualifications)
